

**TERMS AND CONDITIONS FOR APPLICANTS OF MEMBERS OF CHILD WELFARE
COMMITTEE (CWC)**

1. Applicant must be a domicile of the respective districts and will maintain his/her headquarter as the presence is required even at odd hours or on short notice and the appointment will be cancelled if headquarter is not maintained.
2. All conditions from (i) to (vii) of the following point must be fulfilled by the applicant: -
 - (i) has any past record of violation of human rights or child rights.
(Section 27 (4) (A) (i) of the Amended Juvenile Justice Act, 2021)
 - (ii) has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence.
(Section 27 (4) (A) (ii) of the Amended Juvenile Justice Act, 2021)
 - (iii) has been removed or dismissed from service of the Government of India or State Government or an undertaking or corporation owned or controlled by the Government of India or State Government.
(Section 27 (4) (A) (iii) of the Amended Juvenile Justice Act, 2021)
 - (iv) has ever indulged in child abuse or employment of child labour or immoral act or any other violation of human rights or immoral acts, or
(Section 27 (4) (A) (iv) of the Amended Juvenile Justice Act, 2021).
 - (v) is part of management of a child care institution in a District.
(Section 27 (4) (A) (v) of the Amended Juvenile Justice Act, 2021)
 - (vi) A person associated with an organisation receiving foreign contribution shall not be eligible to be a Chairperson or member of the Committee.
(Rule 4 (b) of the Juvenile Justice Amendment Rules, 2022)
 - (vii) Any person working in the implementation of the Act in any Non-Government Organisation or any organisation, performing such functions which may cause conflict of interest in discharge of their duties as the Chairperson or member of the Committee shall not be eligible for appointment as the Chairperson and member of the Committee.
(Rule 4 (c) of the Juvenile Justice Amendment Rules, 2022)
3. Applicant for member of Child Welfare Committee (CWC) shall have to submit an Affidavit in the attached prescribed format along with the Application Form.

4. The Application Form and Affidavit (including documents) must be send/submit in a single pdf file through email at **mizoramicps@gmail.com** *or* in the office of concerned District Child Protection Officer, Women and Child Development **within 15 days** from the date of issue of the advertisement.
5. The Department have reserved the right to reject incomplete application form without any prior notice of the candidate.
