

**TERMS AND CONDITIONS FOR APPLICANTS OF MEMBERS OF JUVENILE
JUSTICE BOARD (JJB)**

- 1) Applicant must be a domicile of the respective districts and will maintain his/her headquarter as the presence is required even at odd hours or on short notice and the appointment will be cancelled if headquarter is not maintained.
- 2) All conditions from (i) to (iv) of the following point must be fulfilled by the applicant: -
No person shall be eligible for selection as a member of the Board, if he/she —
 - (i) has any past record of violation of human rights or child rights;
(Section 4 (4) (i) of the Juvenile Justice Care and Protection of Children Act, 2015)
 - (ii) has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence;
(Section 4 (4) (ii) of the Juvenile Justice Care and Protection of Children Act, 2015)
 - (iii) has been removed or dismissed from service of the Central Government or a State Government or an undertaking or corporation owned or controlled by the Central Government or a State Government;
(Section 4 (4) (iii) of the Juvenile Justice Care and Protection of Children Act, 2015)
 - (iv) has ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act.
(Section 4 (4) (iv) of the Juvenile Justice Care and Protection of Children Act, 2015)
3. Applicant for member of Juvenile Justice Board (JJB) shall have to submit an Affidavit in the attached prescribed format along with the Application Form.
4. The Application Form and Affidavit (including documents) must be send/submit in a single pdf file through email at **mizoramiceps@gmail.com** or in the office of concerned District Child Protection Officer, Women and Child Development **within 15 days** from the date of issue of the advertisement.
