Eligibility Criteria:

- 1. Educational Qualification:** Graduate from any recognized University or Diploma in Public Health and Sanitation / Diploma in Sanitary Inspector Training Course from a Government recognized Institute.
- 2. Age Limit:** A candidate must not be less than 18 years and not more than 37 years of age on the last date of application (upper age limit is applicable till December, 2024 as per Govt. Notification No. A. 12018/31/2020-P&AR(GSW) dt. 10.03.2023). Further relaxation to the upper age limit will be as per Notification No. A-12011/1/2019-P&AR(GSW) dt. 3.6.2019.
- 3. Mizo Language Proficiency:** A candidate must achieve a minimum score in the qualifying test of Mizo Language Proficiency as prescribed by the Government from time to time. However, a candidate who studied Mizo subject in Class – X standard or above within Mizoram or who opt for Mizo subject as MIL outside Mizoram is exempted from taking the qualifying test paper.
- 4. Computer Proficiency:** Computer Proficiency as prescribed by the Mizoram Group 'A', 'B' and 'C' posts Service / Recruitment (Amendment) Rules, 2023 notified vide No. A. 12018/31/2020-P&AR(GSW) dt. 10.03.2023.

- 2. Age Limit:** A candidate must not be less than 18 years and not more than 37 years of age on the last date of application (upper age limit is applicable till December, 2024 as per Govt. Notification No. A. 12018/31/2020-P&AR(GSW) dt. 10.03.2023). Further relaxation to the upper age limit will be as per Notification No. A-12011/1/2019-P&AR(GSW) dt. 3.6.2019.
- 3. Mizo Language Proficiency:** A candidate must achieve a minimum score in the qualifying test of Mizo Language Proficiency as prescribed by the Government from time to time. However, a candidate who studied Mizo subject in Class – X standard or above within Mizoram or who opt for Mizo subject as MIL outside Mizoram is exempted from taking the qualifying test paper.
- 4. Computer Proficiency:** Computer Proficiency as prescribed by the Mizoram Group 'A', 'B' and 'C' posts Service / Recruitment (Amendment) Rules, 2023 notified vide No. A. 12018/31/2020-P&AR(GSW) dt. 10.03.2023. Typing speed of 30 words per minute.

Duly filled application form along with all relevant documents may be submitted to Directorate of UD&PA. Examination Fee @ Rs. 150/- (for ST/SC/OBC) or Rs. 200/- (General Category) should be submitted at the time of submission of Application Form.

Those who are in the Government Service must apply through proper channel. Canvassing directly or indirectly will disqualify the Candidate.
